On account of the interconnectedness of the activities of Flinter, a combined report has been prepared, which includes the reports for the period of the moratorium on payments of various companies belonging to Flinter.

The report contains a representation of facts become known to the administrators/trustees. The information provided to the administrators/trustees is the subject of further investigation. The administrators/trustees note that it may become apparent at a later stage that information mentioned in this report must be adjusted. Accordingly, no conclusion may as yet be drawn about the completeness and correctness of the data included in this report.

No attempt is made with this report to account for the condition of the estate or to provide complete insight.

No rights can be derived from this and subsequent reports. The administrators/trustees accept no liability for any inaccuracies in and/or incompleteness of the report.

This report and the subsequent reports will be published in Dutch and (with some delay) in English. The Dutch version will prevail. This report is identical to the report submitted digitally.

Pursuant to resolutions of 11 January 2018, Ms F. Damsteegt-Molier was appointed examining judge in lieu of V.M. de Winkel as from that date

As from 11 January 2018, A.J. van Steenderen has resigned as trustee.

The trustee has asked the examining judges to propose to the district court that the bankruptcies of Flinter Agencies B.V., Flinter Groningen B.V., Flinter Timechartering B.V., Flinter Newbuilding and Brokerage B.V., Flinter Chartering B.V., Flinter Bareboat B.V., Flintersky B.V., Flinterbright B.V. and Flinterbay B.V. be completed. Separate (final) reports in said bankruptcies were filed on 26 April 2018. This seventh report is a combined report in the other bankruptcies.

The trustee has asked the examining judges to propose to the district court that the bankruptcies of C.V. Scheepvaartonderneming Flintersky II., Flinterstream B.V. and Flinterbirka B.V. be completed. In decisions of 21 May 2019 the District Court ordered the lifting of these bankruptcies. This eleventh report is a combined report in the other bankruptcies.

II. GENERAL INFORMATION

Flinter Groep B.V. is the holding company of the shipping company operating under the name "Flinter" ("Flinter"). Flinter is a shipping company of medium size that used to be active as a provider of sea transport and vessel management services. Flinter's fleet consisted of multipurpose and container feeder vessels, varying in size from 3,000 to 11,000 tonnes. At the time of the bankruptcy Flinter



owned 28 vessels (partly through a participation). The navigation area comprised the Atlantic region and the east coast of America and South America.

Flinter was in charge of the management of approximately 50 vessels, including those belonging to the Flinter fleet. In addition to the commercial management (chartering), Flinter also carried out the technical and crewing management (maintenance, provisioning, ISM, crewing and certification) of the vessels.

Flinter was also active as an initiator of investment projects for the new construction or purchase of vessels; as such, it would seek investors and ensure that contacts between those investors and the shipping companies belonging to Flinter Groep were maintained.

Flinter is established in an office building on the A29 motorway, at Krakau 3, Barendrecht. Flinter also used to have offices in Istanbul, Gdynia (Poland), Antwerp and Vaasa (Finland). The administrative organisation employs 65 people. A total of 400 seafarers are involved – salaried or otherwise – in the shipping companies affiliated to Flinter.

The office staff and 54 seafarers are employed with Flinter Shared Services B.V. Most of the other seafarers are employed with foreign crewing agents.

III. HISTORY

The company started in 1989 in Groningen, with the purchase of the 3,000-tonne multipurpose vessel MV Flinterborg. From its incorporation onward, Flinter grew steadily. In 2000, Flinter took over Rotterdam freighting and forwarding office Ancora Shipping. In 2006 the companies were merged and the merged company continued under the Flinter name as a provider of sea transport and vessel management services in the newly set up office at Barendrecht.

Over the years, Flinter brought 7 vessels on the market. These vessels were financed with loans taken out with several banks and financial institutions and were partly financed by private investors. In connection with those investment projects, many shipping companies were incorporated as limited partnerships, with general partners in the shape of private and public limited companies. The legal structure was inspired mainly by tax motives. The management of the shipping companies was carried out by the subsidiary company of Flinter Groep B.V., Maas Participaties B.V.

Some 4,000 private investors participated in the shipping companies; jointly, they invested a total of around EUR 120 million in the Flinter fleet.

Flinter undertook the convening and facilitation of the general members' meetings of the shipping companies. With a view to the communication between the investors and Flinter, participants' committees were appointed as advisory and consultation bodies, to supervise the investors' interests.

IV. MARKET CIRCUMSTANCES

From around 2008, there has been a worldwide slump in the large shipping sector, with cargo vessel overcapacity and a shortfall in cargo supply, resulting in lower freight rates. According to its



management, Flinter has also been affected by the consequences of this slump. As a result, the operation of cargo vessels has been (greatly) loss-making in recent years.

In the past years, Flinter implemented various restructurings. In 2005, ING Bank made a credit facility available to Flinter. The restructurings took place in consultation with ING Bank. In 2013, for example, a part of the fleet that was being financed by ING Bank was placed in a company incorporated for that purpose, Flinter Fleet Holding B.V. This concerned nine vessels: the Flinter America, Flinter Arctic, Flinter Rose, Flinterbothnia, Gerarda, Orcana, Flinterspirit, Flintersun and Flinterstar. Flinter Fleet Holding B.V. received 100% of the shares of the single-purpose ship owners of the said vessels, after which the general partners acquired ownership percentages varying from between 7 to 15% from Flinter Fleet Holding B.V. In the years that followed, various talks were held with ING Bank on the principle of safeguarding the continuity of Flinter's activities.

Halfway through 2016, after the management had ordered for a quick scan of the organisation to be made by a third party at the instigation of ING Bank, a far-reaching restructuring of personnel took place. In the context of this restructuring, ING Bank relinquished the grounds for calling in the financing provided to Flinter for a period up to 1 October 2016.

On 3 October 2016 ING Bank announced that the credit facilities would not be continued. Subsequently, by letters of 12 October 2016 ING Bank cancelled and called in the financing provided. Under those circumstances, the management of Flinter Groep B.V. and several subsidiaries were forced to apply for a moratorium on payments, on 19 October 2016.

In the context of calling in and cancelling the credit, ING Bank blocked the bank accounts held by Flinter with this banking institution, which also included the bank accounts held by Flinter Shipping B.V. and the bank accounts held for the benefit of the vessels whose earnings and expenditure were shared between them in the geared pool and the gearless pool, respectively, as set up by Flinter. The vessels that participated in those shipping pools were not just financed by ING Bank but also by other banking institutions: Bremer Landesbank, Rabobank, ABN AMRO Bank and Cat Finance. Now that the freight monies could no longer be paid, the shipping companies participating in the pools could no longer meet their obligations vis-á-vis the financing banks, which led to also Bremer Landesbank, Rabobank, ABN AMRO Bank and Cat Finance cancelling and calling in their loans.

V. PERIOD AS FROM 18 OCTOBER 2016

After a moratorium on payments was granted to Flinter Groep B.V. and several subsidiaries on 19 October 2016, Flinter's activities were continued where possible, with a view to a possible relaunch. In consultation with the financing banks, the administrators conducted a sales procedure. Prospective purchasers received a Memorandum Invitation to Tender Procedure Flinter Groep. Several of them made a bid by sending in the Tender Document; however, the bids received were not acceptable to the financing banks. The banks rely on valuations made on their behalf in this respect; by now, several banks have decided on a public sale of the vessels mortgaged to them.

On 7 December 2016, by orders of Rabobank an auction took place of the first Flinter vessel, MV Flinterbirka. On 13 December 2016, also by orders of Rabobank MV Flinterstream will be auctioned. At the instructions of ING Bank, the MVs Flinterbothnia, Orcana, Flintersun, Flinterspirit, Flinter



America, Flinter Rose, Gerarda and Flintersky are to be auctioned on 19 December 2016. Accordingly, a comprehensive liquidation of Flinter has become inevitable.

Since it turned out that there was no prospect of satisfying the creditors in the manner provided in Article 242 Dutch Bankruptcy Act, on 8 November 2016 the administrators asked the District Court to cancel the moratoria on payments and to declare the bankruptcy of the legal entities in question. This did not apply to the moratoria on payments granted to Flinter Shipping B.V. and Flinter Management B.V., since the management activities were continued by these companies. By now, the management of nearly all the vessels belonging to the Flinter fleet has been transferred to other managers. In the short term, also the moratoria on payments granted to Flinter Shipping B.V. and Flinter Management B.V. will be converted into bankruptcies.

VI. COOLING-OFF PERIOD

The bankruptcy judges have ordered a cooling-off period of two months in all the provisionally granted moratoria on payments or bankruptcies. During this cooling-off period, third parties are unable to demand the surrender of their goods as held in the custody of either the administrator/trustee or the party subject to a moratorium/bankruptcy, other than by authorisation of the bankruptcy judge.

1.3 Ongoing litigation proceedings

As far as the administrators/trustees are aware, Flinter is party to the following legal proceedings:

Flinter Shared Services B.V., Flinter Management B.V. and 13 other Flinter companies/Coöperatieve Rabobank U.A.

On 16 March 2016, the District Court of Rotterdam rendered judgment in the case with case and cause list number C/10/461757/HA ZA 14-1055 between the Flinter companies as claimants and Rabobank as defendant. The District Court rejected the claim, ordering Flinter et al. to pay the costs. The essence of the dispute between the parties regards the question whether Rabobank has violated its duty of due care vis-à-vis the Flinter companies through the manipulation of the Euribor interest by its (Rabobank's) employees, at any rate, whether the interest swap agreements between the parties are revocable on account of (mutual) error. Flinter has filed an appeal from this judgment. The statement of appeal is on the cause list for 13 December 2016.

The trustees have requested The Hague Court of Appeal to stay the case on the docket of 13 December 2016. The trustees did not yet have access to the complete litigation file and, in order to determine a position with regard to the continuation of the proceedings, required further information with regard to the backgrounds of the proceedings. Moreover, the trustees still needed to consult with ING Bank, which has a right of pledge on the claim. However, The Hague Court of Appeal has rejected the trustees' request and automatically struck off the case. A definitive position with regard to the restart and continuation of the proceedings has not yet been determined.

Flinterstar III B.V./Owners Al Oraiq

This concerns litigation between the owners of the Flinterstar and the Al Oraiq, in respect to a collision that took place on the North Sea near Zeebrugge on 6 October 2015.

Flinterstar III B.V. is not bankrupt, so the estates of the bankrupt companies are not involved in the proceedings ongoing between Flinterstar III B.V. and the Owners Al Oraiq. Flinter Shipping B.V. and Flinter Group B.V. are involved in proceedings related to the collision between the MV Flinterstar and the MV Al Oraiq. It concerns proceedings initiated by the Belgian State, the Flemish Region and the Flemish Community regarding the costs of wreckage removal. Furthermore, Flinter Shipping B.V. and Flinter Group B.V. have been summoned by the Belgian State on 19 December 2016. In these proceedings, the Belgian State claims compensation for the damage resulting from pollution from bunker oil after the collision. Besides Flinter Shipping



B.V. and Flinter Group B.V., the Owners Al Oraiq were summoned by the Belgian State. These proceedings will take place on 6 April 2017.

As indicated in the previous report, the Belgian State, the Flemish Region and the Flemish Community brought proceedings against Flinter Shipping B.V. and Flinter Groep B.V., among others, in respect to wreck clearing costs.

The Belgian Government started to clear the wreck of the sunken vessel Flinterstar in its official capacity. Limitation of liability had been invoked on behalf of Flinterstar's owner. In the matter at hand, the Belgian government had ordered both the owner of the Flinterstar and the owner of the Al Oraig to remove the wreck of the Flinterstar. The Court of Appeals in Ghent had decided that the Belgian Government was rightly taking the position that a vessel's owner can be obliged to clear a wrecked vessel, even if that owner had limited its liability. Flinterstar III B.V., Flinter Shipping B.V. and Flinter Groep B.V. brought an appeal in cassation against the said decision, before the Court of Cassation of Belgium. On 13 January 2017 the Court of Cassation quashed the earlier decision of the Court of Appeals in Ghent. As a result of the decision of the Court of Cassation the Belgian Government can no longer order the owner of a wrecked vessel to salvage that vessel if that owner invokes a limitation fund. In that case, the Government will have to accept the limitation fund and do the removal work itself. The P&I Club of the Flinterstar (British Marine) made specific payments to the Belgian Government, over and above the Flinterstar's limited liability fund; in view of the Court of Cassation's decision, the P&I Club now wants to claim those payments back from the Belgian Government. Since the orders for wreck clearing were addressed to Flinter Shipping B.V. and Flinter Groep B.V., this will require those companies' cooperation. A court expert had been appointed to determine the sum that was spent, and charged to the British marine, as a result of the wreck clearing order illegitimately imposed by the Belgian Government.

In the proceedings pending before the Court of Appeal with regard to the wreck removal, oral arguments have been scheduled. They will take place in June 2019. In the proceedings for the determination of damages, statements will be exchanged at the end of 2020/early 2021.

In a final judgement of 9 September 2019 the Court of Appeal Antwerpen declared the claims of the Belgian State, the Flemish Region and the Flemish Community against Flinterstar III B.V., Flinter Shipping B.V. and Flinter Groep B.V. unfounded. The claims were related to the costs in relation to the clearing of the sunken vessel Flinterstar.

In relation to the proceedings between the insurance companies of the vessel Flinterstar against the Owners Al Oraiq, the trustee granted permission to bring the case to the court in the name of Flinterstar III B.V. In respect to these activities, a contribution of EUR 7.052,16 was paid.

Flinter Shared Services B.V./W.M. Bloem

This concerns proceedings pending before the District Court of The Hague regarding a claim pursuant to a monetary loan. The case is to be heard on 14 December 2016; the defendant is to produce a statement of defence.

An agreement has now been reached with Mr Bloem regarding an amicable settlement. After the settlement has been fulfilled, the proceedings will be struck off



Flinter Shipping B.V./Port authorities of Finland

These are proceedings pending before the Supreme Court of Finland regarding the repayment of fairway dues. On levying those dues, incorrectly a distinction was made between EU and non-EU countries. Flinter Shipping together with other shipping companies is the claimant in these proceedings. The trustees are investigating what stage this litigation has reached.

The court in Finland has order the Finnish State in first instance to pay damages at the amount of approximately EUR 1 million to various Flinter companies. This judgment was set aside in appeal. Partly at the request of the involved Flinter companies, an application for cassation was submitted to the Supreme Court in Finland. The Finnish State has been given the opportunity to respond to the application by the Supreme Court. After the Supreme Court has decided on the request, it will become clear whether the proceedings can be continued.

The trustees decided on their position in regard to the continuation of the proceedings and spoke to ING Bank as pledgee. ING Bank is deliberating whether to exercise its rights in respect to the current claim.

With the bankruptcy judge's permission an amicable settlement was made pursuant to which a sum of EUR 10,000 was paid. After deduction of the agreed contribution to the estate, of EUR 1,210 inclusive of Dutch VAT, this sum was transferred to the pledgee, ING Bank.

In a judgment of 9 February 2018 the Supreme Court in Finland rejected the applications, for leave to appeal in cassation, of inter alia the relevant Flinter companies.

1.4 Insurances

The bankrupt companies that own cargo vessels are parties to several insurance policies, concerning hull and machinery, loss of hire, and other. These policies have been continued or terminated in consultation with the successor managers. In the case of termination, the managers have ensured that the insurance in question was taken out anew.

Flinter Shared Services B.V. is party to various insurance policies, such as for company liability, transport and equipment. Those policies were continued where necessary for the continuation of business operations.

Flinter Real Estate B.V. is party to an environmental insurance policy; this remains in effect until January 2017.

To the extent that continuation of insurance is unnecessary, policies have been or will be terminated.

By now, all insurance agreements have been terminated.

1.5 Leases

Flinter Groep is not a tenant party to any leases.

Flinter Real Estate B.V. has let out part of the office space at Krakau 3, Barendrecht.

The tenant who rented part of the office space at Krakau 3 in Barendrecht has now vacated and left the office space.

1.6 Cause of bankruptcy

The administrators/trustees refer to what is noted above at IV. The administrators/trustees will make a further investigation of the causes of the bankruptcy of Flinter. The outcomes of that investigation will be announced in one of the next reports.

2. Staff

2.1 Staff numbers at the time of the bankruptcy

At Flinter Shared Services B.V., 65 people are employed at the Flinter office in Barendrecht. In addition, 54 seafarers are employed with Flinter Shared Services B.V.

5 Employees (seafarers) work at Flinter Orcana II B.V.

1 Employee (seafarer) works at Flinter Gerarda II B.V.

In the year preceding the bankruptcy, 160 people were employed at Flinter Shared Services B.V. Halfway through 2016, in the context of the restructuring of personnel mentioned herein above at IV, employment contracts with 35 staff members were terminated.

2.2 Notice of dismissal

After having obtained authorisation thereto from the bankruptcy judges in pursuance of Article 68 (2) Dutch Bankruptcy Act, and taking into account the legal or contractual terms of notice, the trustees sent the employees in question a written notice of dismissal to terminate their employment contracts pursuant to Article 40 Dutch Bankruptcy Act.

After the employment contracts had been terminated, the Dutch Employee Insurance Agency (*Uitvoeringsinstituut Werknemersverzekeringen* UWV) started the so-called intake procedure for the wage guarantee scheme (*Loongarantieregeling*) as provided in the Dutch Unemployment Act. Meetings took place on 3 and 17 November 2016, with UWV field staff explaining the guarantee scheme to the employees and helping them to fill out the requisite forms. By now, payment of the initial advances to the employees has taken place.

In respect to the claims referenced in Article 8:211 DCC (Dutch Civil Code), as arise from the seafarer employment agreements of the captain or other crew members, UWV will not make any advance payments in the context of the wage guarantee scheme for now, since said claims have priority to be paid from vessel proceeds. This priority prevails over the mortgage right on the vessels; the banks who obtained a mortgage right will ensure that the seafarers' claims on their employer are paid. The trustees have passed on the claims of seafarers brought to their notice to the banks in question, each time insisting on urgent payment of those claims. The trustees were unable to prevent that, because of the sometimes-slow decision-making processes at the banks, payment delays were incurred.

An arrangement was established during the second reporting period between ING Bank and employees with a claim with priority on grounds of article 8:211 DCC, and payment of the relevant claims took place based on that arrangement, insofar as they had priority on vessels with a mortgage at the benefit of ING Bank.



Insofar as the banks with a mortgage right on vessels have not yet begun payment of claims of employees, the Dutch Employee Insurance Agency (Uitvoeringsinstituut Werknemersverzekeringen, UWV) has offered to pay an advance in the context of the wage guarantee scheme (Loongarantieregeling).

After having obtained authorisation thereto from the bankruptcy judges in pursuance of Article 68 (2) Dutch Bankruptcy Act, and taking into account the legal or contractual terms of notice, the trustees sent the employees working for CV Scheepvaartonderneming Flinter Pioneer and CV Scheepvaartonderneming Flinter Rachel, which were declared bankrupt during the second reporting period, a written notice of dismissal to terminate their employment contracts.

2.3 Activities

The administrators/trustees informed the Barendrecht office staff during several meetings. The trustees requested that the bankruptcy judges authorise them to terminate the employment contracts and subsequently sent written notices of dismissal. Consultations have taken place between the trustees and UWV in the context of the wage guarantee scheme.

The trustees have consulted with the Dutch Human Environment and Transport Inspectorate (Inspectie Leefomgeving en Transport ILT) concerning the situation on board of several cargo vessels. The ILT checks whether the Dutch shipping industry complies with the national and international rules and regulations. In that context, ILT monitors sea-going vessels under the Dutch flag and supervises the security of the vessels and safety of the crew. ILT has discussed with the trustees the complaints it had received from crew on board several vessels belonging to the Flinter fleet.

The trustees have sent written notices of dismissal to terminate the employment contracts of the employees working for CV Scheepvaartonderneming Flinter Pioneer and CV Scheepvaartonderneming Flinter Rachel.

With the examining judges' permission the trustee reached agreement with two (seafaring) Flinter employees about the recognition of their claims for back wages, priviliged pursuant to Article 8:211 DCC. Sums of EUR 3,000 per employee are concerned.

3. Assets

Immovable property

3.1 Description

The premises at Krakau 3, Barendrecht (land registration: municipality of Barendrecht, section B number 8088 partly, and municipality of Barendrecht section B numbers 3886 and 5977) are the property of Flinter Real Estate B.V.

3.2 Sales proceeds

The trustees will take in hand the sale of the immovable property in consultation with the mortgage holder, ING Bank.

With the bankruptcy judge's permission, by purchase agreement of 11 April 2017 the trustees sold the property at 3, Krakau, Barendrecht to De Haas Automotive Services B.V., established

at Dordrecht. The sale proceeds came to EUR 2,550,000 in contribution to the estate; the transfer took place on 1 May 2017.

In the context of offsetting the property tax and water authority levies for 2017, the notary paid a sum of EUR 2,665.54 into the liquidation account.

3.3 Sum of mortgage EUR 5,600,000.

3.4 Trustees' fee or percentage

Not yet known.

The trustees have agreed with ING Bank on a fee of 1.5% of the purchase price up to EUR 2.4 mln and 15% of everything above that.

Based on the arrangements made with ING Bank the contribution to the estate is EUR 70,785 inclusive of Dutch VAT. This sum was added to the liquidation account.

3.5 Activities

Search of the land register and consultation with mortgage holder ING Bank. Inclusion of immovable property in the Invitation to Tender and contacts with several interested parties.

The immovable property has been viewed by a number of interested parties during the second reporting period. The trustees have provided these interested parties with the requested information.

In the course of the third reporting period the trustees spoke to several candidate parties and negotiated with the purchaser about the terms and conditions for the sale. The trustees also drew up a purchase agreement

Operating assets

3.6 Description

The office equipment in the offices at Krakau 3, Barendrecht is the property of Flinter Shared Services B.V.

3.7 Sales proceeds

The trustees will take in hand the sale of the office equipment.

With the permission of the bankruptcy judges the trustees have sold the ship models of the MV Flinterborg and the MV Flinterstar to the Maritime Museum in Rotterdam at a purchase price of EUR 6,050. The Maritime Museum in Rotterdam made an offer for the models of the MV Flinterborg and the MV Flinterstar because the museum would like to add these models to its collection of photo and film materials, shipping company flags of Flinter et cetera, which the Maritime Museum Rotterdam already owns.

The trustees have sold telephones and laptops to former employees of Flinter Shared Services B.V. The proceeds amount to EUR 3.297,10. The trustees have further sold a burst image of one of the founders. The proceeds amount to EUR 665,50.

The company inventory will be sold through an online sale to be organised by Van Beusekom Registermakelaars | Taxateurs | Veilinghouders. The auction is expected to start on 30 March 2017. The trustees refer to the website www.beusekom.nl.

The online auction of the office furniture and equipment and stock items of Flinter Shares Services B.V. took place from 30 March through 12 April 2017. Sales proceeds amounted to EUR 146,293.20 inclusive of Dutch VAT.

3.8 Trustees' fee or percentage

Not yet known.

Now that under the tax collection act, office furniture and equipment are considered property found on the premises, a contribution to the estate is not relevant in their regard.

3.9 Right of seizure by the tax authorities

Based on Article 22 (3) in conjunction with Article 21 (2) of the Dutch Collection of State Taxes Act of 1990 the tax authorities have priority to be paid from the proceeds of property found on the premises, which priority prevails over any pledgees' rights of pledge to such property.

3.10 Activities

The trustees have requested that Van Beusekom Registermakelaars l-Taxateurs l-Veilinghouders appraise the office equipment.

During the second reporting period the trustees have made agreements with Van Beusekom Registermakelaars | Taxateurs | Veilinghouders regarding the conditions at which the online auction will be undertaken.

In respect to the online auction mentioned at 3.7 above the trustees consulted on the sale with Van Beusekom Registermakelaars I Taxateurs I Veilinghouders. The trustees also ensured that any administrative documents in the offices were removed.

Stocks / work in progress

3.11 Description

The premises at Krakau 3, Barendrecht contain various stock items. These mainly concern (reconditioned) ship engine parts. Since after replacement, parts would usually be reconditioned to be placed in other vessels, it is impossible for the trustees any longer to ascertain to what company the stocks in question belong.

3.12 Sales proceeds

The trustees will take in hand the sale of the stock.

Part of the stock items was sold with permission of the bankruptcy judges. The sales proceeds were EUR 40,000 ex VAT.

The unsold stock items will be sold through an online sale to be organised by Van Beusekom Registermakelaars | Taxateurs | Veilinghouders. The auction is expected to start on 30 March 2017. The trustees refer to the website www.beusekom.nl.

The online auction of the stock items of Flinter Shares Services B.V. took place from 30 March through 12 April 2017. Sales proceeds amounted to EUR 67,228.21 inclusive of Dutch VAT.

3.13 Trustees' fee or percentage Not yet known.

The trustees and ING Bank have differing opinions regarding the question of whether the inventory items bear a legally valid right of pledge. The sales proceeds of the inventory items will be deposited to the third party account of the trustees while awaiting an amicable settlement or legal decision regarding this matter.

The total sales proceeds of EUR 115,628.21 inclusive of Dutch VAT were paid into the trustees' clients' account, pending an amicable settlement or court decision in regard to the question whether a legitimate right of pledge rests on the stock items.

3.14 Activities

The trustees have listed the various stocks and are making preparations for their sale.

In respect to the online auction the trustees consulted on the sale with Van Beusekom Registermakelaars I Taxateurs I Veilinghouders.

The trustees refer to the description of other assets in 3.16 below.

In a previous report, a dispute was mentioned between the trustees and Bremer Landesbank (now NordDeutsche Landesbank) about the question whether the bank's mortgage right also comprised the deck equipment on board m/v CRS Rebecca. In regard to this dispute, a sum of EUR 175,000 was credited to the trustee's client's account upon the transfer of the m/v CRS Rebecca. During the reporting period the trustee, reserving the examining judges' permission, reached agreement on the division on the sum in question; this will be discussed in a subsequent report.

The arrangement with Norddeutsche Landesbank regarding the deck equipment aboard the m/v CRS Rebecca as referred to in the previous report entails that an amount of EUR 67,500 has accrued to CRS Rebecca B.V.'s assets. Having regard to the fact that the deck equipment must be regarded as a ship's appurtenances within the meaning of Article 8:1(4) of the Dutch Civil Code and falls under the bank's mortgage right, a result has been achieved with regard to the aforementioned division of the sum in question that is acceptable to the creditors.

In the eighth report the trustee advised of the receipt of positive balances on the bank accounts of Flinter Groep B.V. One of these bank accounts however turned out to be in the name of C.V. Scheepvaartonderneming Flinterbelt II. This partnership has not been declared bankrupt. The trustee therefore paid the balance of this bank account (EUR 1,434.93) to the managing partner of C.V. Scheepvaartonderneming Flinterbelt II.

3.16 Sales proceeds

Not yet known.

The public sale of the MV Flinterduin and the MV Flinterdijk will take place on 14 March 2017 at the instruction of ABN AMRO Bank N.V. in the presence of notary A.H. Geerling in Rotterdam. At the same time the public sale of the MV Flinterbay and the MV Flinterbright will take place at the instruction of Caterpillar Financial Services Corporation in the presence of Mr Geerling.

On 14 March 2017 the public sale of m/v Flinterduin and m/v Flinterdijk took place. The vessels were sold to Longduin Shipping B.V.; proceeds were EUR 2,650,000 each.

Also on 14 March 2017, the public sale of m/v Flinterbay and m/v Flinterbright took place. The vessels were sold to Caterpillar Financial Services; proceeds were EUR 2,095,000 each. Since the vessels were sold to a foreign company the ships were deregistered from the Dutch land registry. The trustees helped realise this deregistration and stipulated an estate contribution per vessel of EUR 1,875 exclusive of Dutch VAT, which sums were paid into the liquidation account.

Flinter Participaties B.V. had a claim of EUR 55,484 on limited partnership Ruby Shipping C.V., which claim was sold to Ruby Shipping C.V. with the magistrates" permission. The trustees and ING Bank agreed on a contribution to the estate of EUR 2,000 exclusive of Dutch VAT. This contribution was paid into the liquidation account.

The trustees cooperated in the sale and transfer of the shares in Jorvik B.V. held by Maas Participaties B.V. In respect to this transaction, an estate contribution of EUR 2,000 exclusive of Dutch VAT was agreed; this contribution was paid into the liquidation account.

The trustees cooperated in the sale and transfer of the shares in private companies Flinter Diana B.V. and Flinter Erica B.V. indirectly held by Flinter Groep B.V. The purchase sum was EUR 10,000; this was paid into the liquidation account.

During the reporting period a sum of EUR 128,075.89 was received from a crew manager, who was in charge of the crew management of a number of Flinter vessels. Flinter had paid an advance to the crew manager, out of which to pay Flinter employees. The unused part of that advance was reimbursed and paid into the liquidation account.

At the request of Bremer Landesbank and with the permission of the magistrates the trustees are rendering their cooperation to the sale of motor vessels Flinterland, Flinter Aland, Flinter Atlantic, Flintermar, Flinter Rachel and Pioneer. A right of mortgage of Bremer Landesbank rests on these vessels. The vessels will be transferred in the next reporting period.

Bremer Landesbank also asked the trustees for their cooperation in the sale of m/v CRS Rebecca. Changes were made to this vessel in 2014, so that it might be used for cable recovery activities. On board the vessel is deck equipment consisting of a winch, a tensioner and a propulsion system, among other things. The trustees consider the deck equipment movable property unencumbered by a security right of the bank, and to the proceeds of which the estate is entitled. Bremer Landesbank takes the position that the deck equipment is a component of the vessel. To let this discussion impede the sale of the ship no longer, the trustees with the magistrates' permission agreed with Bremer Landesbank that cooperation will be rendered to the sale of the vessel and that EUR 175,000 of the sale proceeds will remain on deposit with the notary until there is a res judicata judgment to show whether the deck equipment should be considered movable property or a component of the vessel.

During the reporting period, a refund of EUR 11.99 was received from Post.nl.

With the examining judges' permission, the Trustees sold and transferred Flinter Participaties B.V.'s claim pursuant to a monetary loan of EUR 55,484 on Ruby Shipping C.V., to Ruby Shipping C.V., so as to be able to delete a right of mortgage on m/v Ruby that had served to secure the claim in question. The purchase sum for the claim was EUR 5,000.

In the course of the reporting period, a refund of EUR 181.21 was received from Anker Verzekeringen.

During the reporting period, the current manager of m/v Jorvik requested that the Trustees transfer the books and account of the C.V. in question. The Trustees stipulated a fee of EUR 1,089 inclusive of Dutch VAT for this, which sum has since been deposited in the bankruptcy account. Said sum regards compensation of the costs charged to the Trustees by the company that stores the books and accounts.

During the fifth reporting period, in the presence of civil-law notary A.H. Geerling (NautaDutilh) the transfer took place of motor vessels Flinter Atlantic (now m/v Rotterdam) and m/v Flinter Aland (now m/v Riga). In the presence of civil-law notary T.J. van Vuren (NautaDutilh) the transfer took place of motor vessels Flinter Pioneer (now m/v Rome), Flinter Rachel (now m/v Rachel), and CRS Rebecca.

The remaining fees of EUR 25,000 per ship, i.e. EUR 125,000 in total, were credited to the liquidation account. After the transfer of m/v CRS Rebecca a sum of EUR 175,000 was credited to the trustees' clients' account. As was noted in the third report, this sum will remain on deposit until there is a res judicata judgment to show whether the deck equipment should be considered moveable goods or part of the vessel. Consultation on this took place between the trustees and counsel of Norddeutsche Landesbank; however, the issue has not been resolved yet.

The earlier concluded purchase agreement regarding m/v Flintermar was rescinded during the fifth reporting period. With the examining judges' permission, the vessel in question was sold to another buyer at a purchase price of EUR 4,250,000.

During the sixth reporting period, balances from various bank account were received: the balance of the bank account of Flinter Rebecca B.V. of EUR 6,799.62, the balance of the bank account of Flinter Pioneer B.V. of EUR 49.02 and the balance of the bank account of Flinter Rachel B.V. of EUR 5,929.40.



As to m/v Flintermar, during the sixth reporting period the remaining estate contribution of EUR 25,000 was transferred so that also in regard to this vessel, a sum of EUR 50,000 has now been received.

During the sixth reporting period, with the examining judges' permission the trustees sold participations held by Flinter Participaties B.V. in shipping companies Nordic D C.V. and Nordic E C.V. at a purchase price of EUR 10,000 per participation. The purchase sums have been deposited into the liquidation account.

The trustees also sold the shares held by Flinter Groep B.V in Oy Nordic Chartering AB. Oy Nordic Chartering AB holds the shares in Nordic Diana B.V. and Nordica Erika B.V., managing partners of shipping companies Nordic D C.V. and Nordic E C.V. The purchase sum for the shares was EUR 193,710 and has been deposited into the liquidation account.

During the ninth reporting period, the sale and delivery of the MV BCC Seattle (formerly MV Flinterland) took place. The sale proceeds of USD 4,725,000 were paid to the mortgagee, Norddeutsche Landesbank. The receiver agreed with Norddeutsche Landesbank on a contribution to the estate of EUR 50,000, which amount had already been paid in a previous reporting period.

During the eleventh reporting period the sale of the MV BBC Lagos (formerly: Flinter Tide) and MV BBC Livorno (formerly: Flinter Trader) took place. The proceeds of the sale (USD 5.5 million for each vessel) have been paid to the mortgagee, Norddeutsche Landesbank. The transfer of MV BBC Lagos (formerly: Flinter Tide) has taken place in the meanwhile. The transfer of MV BBC Livorno (formerly: Flinter Trader) will take place in July 2019. The trustee agreed with Norddeutsche Landesbank on a fee to be paid to the trustee of EUR 50,000 for each vessel, which amount had already been paid in a previous reporting period. Now that the sale of MV Flinter Tide and MV Flinter Trader has taken place, all vessels belonging to the bankrupt Flinter companies have been sold.

On 12 June 2019 the delivery of the BBC Lagos (formerly: Flinter Tide) and the BBC Livorno (formerly: Flinter Trader) took place. All vessels belonging to Flinter fleet have been delivered to the buyers of the ships.

3.17 Activities

The trustees have had extensive consultations with the banks to find out what mortgage rights have been established on the cargo vessels.

In respect to the transactions described in 3.16 above the trustees consulted with mortgage holders ABN AMRO Bank N.V. and Caterpillar Financial Services, pledgee ING Bank, the notaries in whose presence the sale of the vessels took place and the deed of transfer of the shares was passed, and with the crew manager. As to the sale of m/v CRS Rebecca and the deck equipment on board this vessel the trustees consulted with representatives and counsel of Bremer Landesbank.

The trustees also requested the magistrates' permission for the transaction described at 3.16 above.

By order of Bremer Landesbank and the Trustees, NTAB made a valuation of the deck equipment on board m/v CRS Rebecca during the accounting period. Bremer Landesbank and the Trustees subsequently received offers for the deck equipment. The Trustees are consulting

with Bremer Landesbank to ascertain whether a solution may be found for the dispute about the question whether the mortgage right extends to include the deck equipment.

The trustees consulted with counsel of Norddeutsche Landesbank about the question whether the mortgage right also includes the deck equipment. The trustees also consulted with the notaries in whose presence the vessels mentioned at 3.16 were transferred.

Consulting with Norddeutsche Landesbank's attorney regarding the deck equipment of the m/v CRS Rebecca and asking the delegated judges permission for the arrangement.

4. Accounts receivable

4.1 Scope of accounts receivable

As per 18 October 2016, Flinter Groep had a sum of circa EUR 7,6 million in receivables. The overview below shows the receivables portfolio of each company. The sums therein have been derived from the outstanding items lists that were found in the financial accounts of Flinter Groep.

The trustees have now analysed the receivables portfolio. This analysis showed that of the total amount to be claimed of EUR 8,009,542, an amount of EUR 7,143,046 is related to intercompany claims.

In respect to the collection of the accounts payable claims, the trustees are consulting with ING Bank as the pledgee for the claims in question.

The trustee wrote to the debtors; this resulted in a considerable number of responses, to be assessed by the trustee.

4.2 Proceeds

The administrators/trustees are investigating the payments that were made into the various bank accounts held by Flinter Groep after 18 October 2016.

5. Banks/Securities

5.1 Bank claims

By agreement of 17 May 2005 ING Bank made available a credit facility to several of the companies belonging to Flinter Groep. Flinter Groep B.V. and its subsidiaries were parties to the financing agreements that were concluded in respect to this financing.

On the date the moratoria on payments were granted, Flinter's debt to ING Bank as pursuant to said financing was circa EUR 18 million.

In addition, ING Bank provided further financing to several shipping companies belonging to Flinter. On the date the moratoria on payments were granted, Flinter's debt to ING Bank as pursuant to said financing was circa EUR 8 million.

ING Bank also provided financing to several subsidiaries of Flinter Fleet Holding B.V., in the context of the construction or purchase of the vessels belonging to those companies. Pursuant to the financing in question, ING Bank has a total claim of EUR 44.5 million.

Bremer Landesbank provided financing to Flintermar B.V., Flinterland B.V., Flinter Pioneer B.V., CRS Rebecca B.V., Flinter Rachel B.V., Flinter Aland N.V., Flinter Atlantic N.V., Flinter Trader

N.V. and Flinter Tide N.V., for a total sum of around EUR 66 million, in the context of the construction or purchase of vessels belonging to the companies in question.

ABN AMRO Bank provided Flinterduin II B.V. and Flinterdijk II B.V. with credit facilities, pursuant to which ABN AMRO Bank has claims for EUR 3,402,398.02 and EUR 3,269,422.70, respectively.

Rabobank has provided Flinter Groep B.V. with financing in the amount of EUR 2 million.

Rabobank provided Flinterbirka B.V. with financing pursuant to which Rabobank has a claim of around EUR 3 million.

CAT Finance provided Flinterbay B.V. and Flinterbright B.V. with financing of EUR 5,490,000 each.

5.2 Lease contracts

Flinter Management B.V. is party to a lease contract regarding life rafts and immersion suits on board the vessels belonging to the Flinter Fleet. The successor managers have continued the lease agreement so that the life rafts and immersion suits can remain on board.

Flinter Shared Services B.V. is party to several lease contracts regarding vehicles. In connection to the continuation of activities, the lease contracts in regard to several vehicles were continued. Where cars could be surrendered and lease contracts terminated, they were.

The vehicles still being used were surrendered to the lease companies in late December 2016.

5.3 Description of securities

To secure compliance with the commitments under the financing mentioned above at VII (5.1), Flinter has created the following securities:

By way of several deeds of pledge, Flinter Groep B.V. and its subsidiaries have created rights of pledge on the operational assets, stocks and book debts for the benefit of ING Bank.

Flinter Real Estate B.V. has granted a mortgage right on the immovable property at Krakau 3, Barendrecht.

In addition, mortgage rights were granted on the vessels mentioned above at 3.15.

The trustees established that ING Bank has started to offset sums against inter alia the money paid into the Flinter Shipping bank account. The trustees take the position that from a specific moment on, ING Bank knew that a bankruptcy of Flinter Groep, including Flinter Shipping, was unavoidable, and from that same moment on, pursuant to article 54 Dutch Bankruptcy Act no longer had the authority to offset any sums, unless ING was making those payments to satisfy claims on which Flinter Shipping had established an undisclosed pledge. The trustees contest that the payments intended above regarded claims pledged to ING Bank by Flinter Shipping. In the contracts of carriage on which said payments were based, Flinter Shipping had acted "as agent" and accordingly, as the relevant ship owners' authorised representative. Flinter Shipping has acquired no collection rights of its own pursuant to this. Accordingly, the claims in question also could not be given in pledge by Flinter Shipping. The trustees informed ING Bank of their



position in writing, requesting that ING Bank pay the sums it had offset in contravention of Article 54 Dutch Bankruptcy Act into the liquidation account.

ING Bank takes the position that Flinter Shipping is entitled to all claims pursuant to freight revenues and that these fall under ING's undisclosed right of pledge. ING also claims that Flinter Shipping established a public right of pledge on the (balances of) bank accounts held at ING Bank and any claims Flinter Shipping has on ING Bank.

The trustees will first investigate whether an amicable settlement of this dispute is an option. In the past reporting period, the trustee made a further investigation of Flinter Shipping's books and accounts and ascertained that in the formation of the contracts of carriage, Flinter Shipping had acted "as agent" (direct representative) of the ship owners in question. Since Flinter Shipping had acted "as agent", Flinter Shipping obtained no rights of claim of its own; accordingly, said claims were also not pledged to ING Bank. The trustee informed ING Bank that he persists in his position that, in view of Article 54 Dutch Bankruptcy Act, the bank has erroneously set off the sums that had been credited to Flinter Shipping's bank account in regard to said claims (some 3.3 million Euros in total). ING Bank has communicated its intention to respond to the trustee's position.

During the period under review, ING Bank's attorney responded to the receiver's position. This response is cause for the receiver to further investigate the freighting files in Flinter Shipping's records.

During the ninth reporting period, the receiver and his associates conducted an extensive investigation into the freight files in Flinter Shipping's records. This investigation confirmed that Flinter Shipping acted "as agent" of the ship owners. Flinter Shipping has acquired no collection rights of its own and the claims could not be given in pledge to ING Bank. ING Bank has offset sums which have been paid into the Flinter Shipping account. The receiver maintains his position that the set-offs took place in breach of Article 54 of the Bankruptcy Act. ING Bank has stated that it maintains its position that the claims were pledged and that set-off was permitted. The receiver is considering legal measures.

The receiver is preparing legal measures against ING Bank.

The trustee intends to issue a writ against ING Bank. The draft writ has been drawn up in the meanwhile. The trustee has applied to the bankruptcy master (rechter-commissaris) for Article 68 paragraph 3 Dutch Bankruptcy Act authorisation to institute proceedings. On 27 May 2019 a discussion was held between the bankruptcy master, ING Bank and the trustee. This discussion served to trigger consultations between the parties. While awaiting the result of these consultations, authorisation by the bankruptcy master has yet to be given.

The consultations as referred to in the previous report aren't finalized until yet.

During the reporting period, further consultations were held with (the lawyers of) ING Bank. A meeting is planned, which will be held in early January 2020. In the next report the creditors will be informed about the outcome of the consultations with ING Bank.

The consultations which were announced in the previous report are held. The trustee has made agreements with ING Bank regarding the proceedings which will be brought to the court, for instance with regard to the legal issues related to the dispute. These legal issues are related to the transfer of amounts and settlements which were carried out by ING Bank with balances in the accounts of Flinter Shipping B.V. The bankruptcy master (rechter-commissaris) has granted the trustee the Article 68 paragraph 3 Dutch Bankruptcy Act authorisation to institute proceedings. The service of the summons is expected in April 2020.

During the reporting period consultations were held between the trustee and ING Banks' attorney regarding the summons. Due to circumstances these consultations take more time than at the time of the submission of the previous report was expected. The service of the summons is expected in July 2020.

The procedure against ING Bank before the court of Amsterdam is currently pending. ING Bank has been granted a stay of proceedings (aanhouding) for filing the statement of defence (conclusie van antwoord) until 14 October 2020.

The procedures consists of three legal matters, namely:

- a) what standard(s) applies (apply) in determining good faith (goede trouw) in the sense of article 54 par. 1/article 235 par. 1 Bankruptcy Act (Faillissementswet) and which facts and circumstances should the judge take in consideration when answering the question from which moment the party that is to set off (verrekenende partij) is no longer acting in good faith?
- b) does article 228 Bankruptcy Act prohibit that the bank, after the date on which the suspension of payment (surseance van betaling) has been granted, without cooperation of the administrator (bewindvoerder), transfers credit balances of the person subject of the suspension of payment to bank accounts of affiliated entities of the person subject of the suspension of payment?
- c) does the exception as set out in judgement Mulder q.q./CLBN (that the silent pledgee (stille pandhouder) is entitled to set off made payments on the for pledgor (pandgever) by pledgee held bank accounts) apply to a situation in which a payment has been made into the bank account that the pledgee holds for a third party (in this case a sister company of pledgor) and not on the bank account that pledgee holds for pledgor?

5.4 Position of secured creditors

To the extent that there are legitimately established securities in the shape of rights of pledge or mortgage, holders thereof are designated secured creditors.

5.5 Trustees' fee

For their cooperation in the liquidation of mortgaged vessels, the trustees have stipulated a fee of EUR 50,000 per vessel.

For the sales efforts conducted by the trustees regarding the immovable property at Krakau 3 in Barendrecht, the trustees have agreed on a fee of 1.5% of the purchase price up to EUR 2.4 mln and 15% of everything above that.

With regard to the collection of the claim on Mr W.M. Bloem (see under 1.3), the trustees have agreed on a fee of EUR 1,000 ex VAT.



During the reporting period the trustees and ING Bank agreed on the estate contributions mentioned at 3.16 above.

5.6 Retention of title

Ten suppliers have invoked retention of title. The trustees are taking stock of the claims of those suppliers who have registered their claim.

Any retentions of title were settled by the trustees. To the extent that these were legitimately stipulated retentions and the goods supplied under those retentions of title were still present, the latter were returned to the suppliers in question.

5.7 Retention rights

The trustees have not become aware of any retention rights being invoked.

5.8 Right of recovery

The trustees have not become aware of any rights of recovery being invoked.

5.9 Activities

The trustees consulted with the banks mentioned at 5.1 above and are investigating the credit relationships in question and the legitimacy of the security rights, as well as the retention rights claimed.

During the reporting period the trustees investigated the legitimacy of the securities stipulated and corresponded with ING Bank about the offsetting described in 5.3 above. The trustees also consulted with suppliers who invoked a retention of title, about the surrender of the goods in question.

6. Relaunch / continuation

Continuation

6.1 Operation / securities

For some time after the moratorium on payments had been granted or, as the case may be, the bankruptcy had been declared, the trustees continued the activities of Flinter. In consultation with the banks that obtained mortgage rights on the vessels, the management of those vessels was transferred to other managers. For the management activities that took place in November 2016 under the directorship of Flinter and the administrators/trustees, the trustees have stipulated compensation in the amount of EUR 278,000. The costs of continuing the office activities over November 2016, which have been estimated at EUR 65,000, will be paid from this sum.

During the reporting period the trustees have reached agreements with banks/financiers on the compensation of the management activities carried out by them. In this case, an amount of EUR 77,000 was paid to the estate during the reporting period, making the current total management compensation EUR 355,000.

The trustees had extensive consultation with the banks about the (conditions for the) transfer of the management activities.

The trustees have consulted with banks/financiers during the second reporting period regarding the compensation for management activities carried out by the trustees. In consultation with the banks/financiers, the activities regarding the commercial and technical management have now been transferred to other managers.

As was outlined herein above, the administrators have investigated whether a relaunch of the business activities might be possible. It has turned out that it is not.

The administrators/trustees conducted a sales procedure in their capacity of administrators; in this context, they sent prospective purchasers a Memorandum Invitation to Tender Procedure. The trustees mapped the bids received and discussed them with the banks.

7. Compliance with the law

7.1 Obligation to keep books

Under investigation.

The trustees have determined that Flinter Groep has fulfilled the obligation to keep books.

7.2 Filing of annual accounts

Under investigation.

Except for the financial statements of Flinter Groep B.V. for 2009 and 2013, the financial statements were published in good time. It follows from the provisions of Article 2:248(2) of the Dutch Civil Code (DCC) that, as the management has not (always) complied with the obligation to publish the financial statements in good time, it has performed its duties improperly and it shall be presumed that the improper performance of its duties constitutes an important cause of the bankruptcy. However, the causes and regularity audit initiated by the receiver has shown that the bankruptcies – as put forward by the management – were caused by the consequences of the financial malaise in the shipping industry, which also affected Flinter. Therefore, the management is able to plausibly argue that facts or circumstances other than manifest mismanagement were an important cause of the bankruptcy.

7.3 Auditors' approval certificate Under investigation.

In the years 2005 through 2015, the auditor issued unqualified opinions.

7.4 Payment obligation shares

Under investigation.

Part of the claims against the shareholders to pay up the shares in full have become prescribed under the provisions of Article 3:307(1) DCC. To the extent the claims have not become prescribed, it has been established that the shares have been paid up in full.

7.5 Mismanagement

Under investigation.

The causes and regularity audit initiated by the receiver did not reveal any indications of manifest mismanagement.

7.6 Fraudulent conduct in respect of creditors

Under investigation.

The causes and regularity audit initiated by the receiver did not reveal any indications of fraudulent conduct in respect of creditors.

7.7 Activities

The trustees have engaged Grant Thornton Forensic & Investigation Services B.V. to take stock of the relevant financial administration and to secure this. This has taken place by now. The trustees will investigate the books and account of Flinter. The trustees will make no representations to third parties about this topic until these investigations are concluded.

During the reporting period, Grant Thornton Forensic & Investigation Services B.V. took charge of the dismantling and storage of servers in the Flinter office.

Single liquidation of bankruptcies/ attribution of salaries to bankruptcies

The Trustees have established that, where the bankrupted legal entities belonging to Flinter Groep are concerned, there is not a situation whereby assets of the separate entities were intermingled to such an extent that it cannot be determined which bankrupted owner possesses specific assets and/or liabilities. No 403 statement was issued, whereas also, not all the bankrupted legal entities made a consolidated report. Under the circumstances, there is no reason for a consolidated liquidation of Flinter Groep, so that in conformity with the main rule, the bankruptcies will be liquidated singly.

The Trustees did ask the examining judges to charge the Trustees' hours to those bankruptcies where assets had been realised, proportionate to those assets. This request by the Trustees is related to the fact that working hours, definitely during the initial, hectic period, are not easily attributable to the separate moratoria and bankruptcies. In the Trustees' provisional estimation, the creditors will not be harmed by such attribution of hours since at best, the assets will suffice to pay the bankruptcy costs and the greatest preferential creditor in the bankruptcy of Flinter Shared Services B.V., the UWV.

Should creditors feel that their interests impede this manner of hours attribution, they may make their objections known to the examining judges. This applies both for the period of the moratoria and for the period of the bankruptcies.
